*Litigation and Settlement in a Game with Incomplete Information* Wolfgang Ryll, 2012-12-06 We investigate a two person game of litigation and settlement with incomplete information on one side So far various theoretical attempts have been made to answer the question of why some people choose not to resolve their disputes and instead go to court and incur litigation costs even if bargaining leaves room for both parties to fare better when avoiding the conflict We can distinguish between games which focus on strategic elements like games with incomplete information see for example P ng 1983 Samuelson 1982 and Schweizer 1989 and decision theoretic models neglecting strategic elements see for example Landes 1971 and Gould 1973 The single person decision theory approach to litigation assumes litigants to have a subjective estimate of the likelihood that the plaintiff will win the action Differing views on the probability of winning the court case help to explain the fraction of cases that actually go to trial Among others P ng 1983 points out the shortcomings of the single person decision theory approach which does not take into account for example the different fee systems in England and the U S and the differences in information conflicting parties may have P ng constructs a model of one sided incomplete information where the settlement terms are given exogenously Schweizer 1989 on the other hand extends P ng s model and allows for two sided asymmetric information where the settlement terms are determined endogenously
