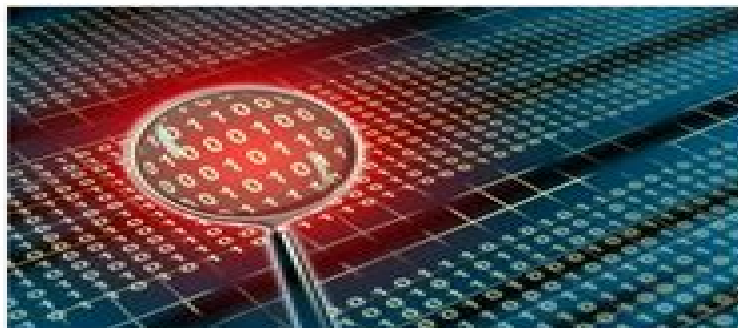


Protecting Your Computer's System
