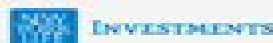
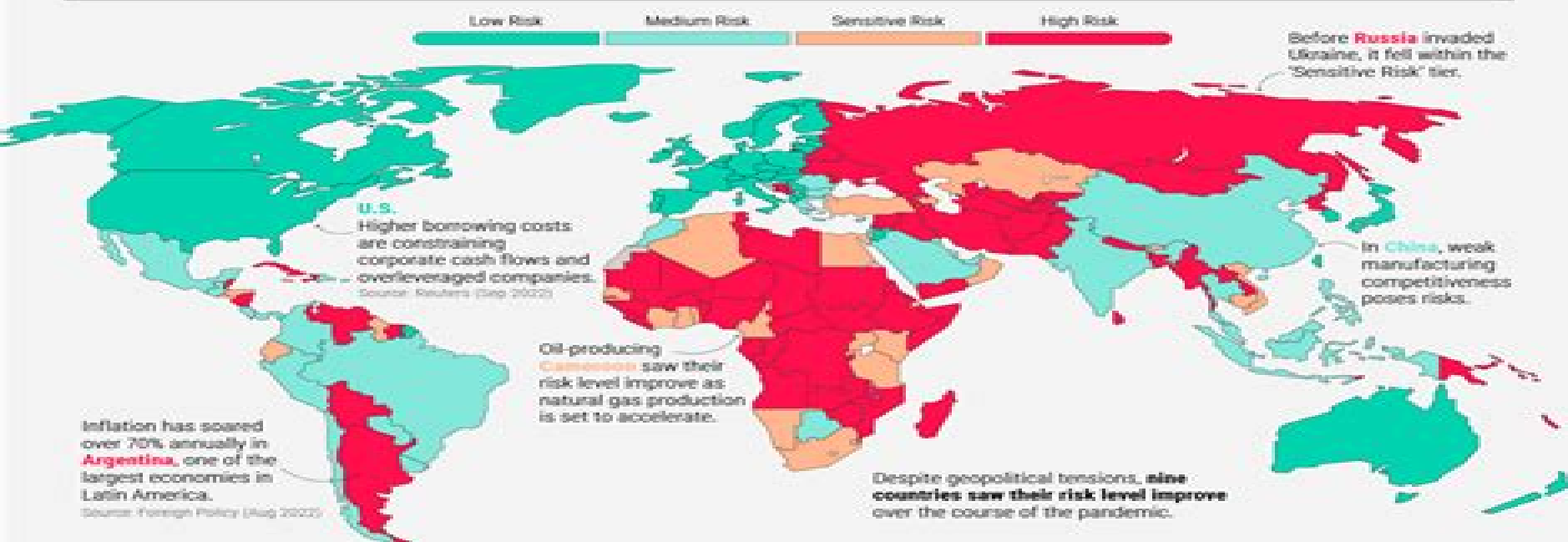


# The 2022 Macroeconomic Risk Map
