quality by pollution discharges is probably the biggest challenge in sustainable water resources management in the recent decades. In practice, most countries have adopted pollution control strategies and measures which are based on end-of-pipe solutions, wastewater treatment plants and adjustments to the regulations including taxes for wastewater discharges.

**Conventional Strategy** Although this approach involves very high costs, on many occasions this strategy has been a complete failure.
