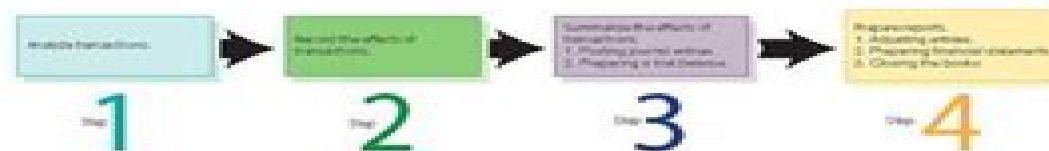


Figure 2.5: Sequence of the Accounting Cycle
