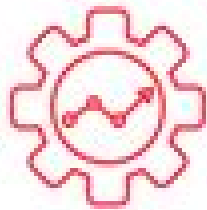
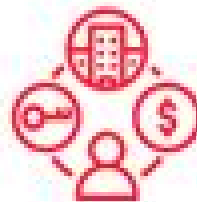

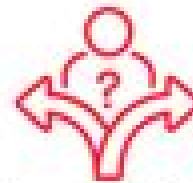

The Logic of Delegation D. Roderick Kiewiet, Mathew D.
