INTRODUCTION - WRITTEN AND UNWRITTEN LAWS

How do legal scholars reason? Words can be subdivided into written or oral ruse. The rule of thumb for Constitutions is that most are written, even though a small percentage of constitutions are not written, for example the constitution of the UK, which is based on customs and traditions.

Written constitutions involve unwritten conventions regarding interpretation. For example, in the USA Trump was impeached twice and the second impeachment began when he was out of office. There is no written provision about whether a president can be impeached when out of office in the American constitution, and so this was left to interpretation.

There are 2 approaches:

- Top down: we formulate a law and then we apply it to specific cases
- Bottom up: we start from a case and according to the decision taken in that case, we formulate a general law

Most of legal rules use the term "shall, which is the most used word in the Italian constitution.

HISTORY OF THE CONSTITUTION

The Italian constitution is a result of a compromise between the different political forces after Mussolini's dictatorship, and it is a reaction to prevent another dictatorship.

The Italian constitution was written in 1948. Before this there was the "Statuto Albertino", written in 1848, which was "octroyée", which means conceded to the people as a courtesy from the king. The Statuto belonged to the kingdom of Piedmont and Sardinia. The different kingdoms in Italy were unified in 1861 and the Statute started ruling the whole Italian territory, and it was the constitution which was enforced during the two world wars, including Mussolini's rise to power in 1922 with the "Marcia su Roma" and his dictatorship. Before that, Italy was a liberal state: the constitution was there, but it was very flexible and the king had the final word, to the point that he had the power to appoint Mussolini as the prime minister. As a reaction to this, our Constitution is rigid.
