International taxation post BEPS has been fraught with new challenges that warranted urgent responses. These challenges were mainly provoked by the unprecedented rise of the digital economy which truly marked a change in the way business is conducted, how value is created and how goods and services are produced and consumed. Digitalization in turn had repercussions on all aspects of taxation: direct taxation, indirect taxation, and even tax procedures. Abundant data from the European Union or the OECD signaled an ever-increasing gap between expected VAT revenues and VAT actually collected, making it obvious that the classical system of VAT/GST collection was unable to respond to challenges posed by the digital economy. Therefore, new solutions based on the participation of digital platforms as intermediaries had been introduced. Finally, new technologies such as blockchain paved new avenues in enhancing tax compliance.
