Instead securities such as shares or bonds are mostly held through intermediaries and transferred by way of book entries on securities accounts. The EU Commission is also running a legislative project to achieve harmonisation at the regional level. This book compares both initiatives and analyses their impact on the securities laws of selected European jurisdictions.
