Step 2: Serve your Spouse

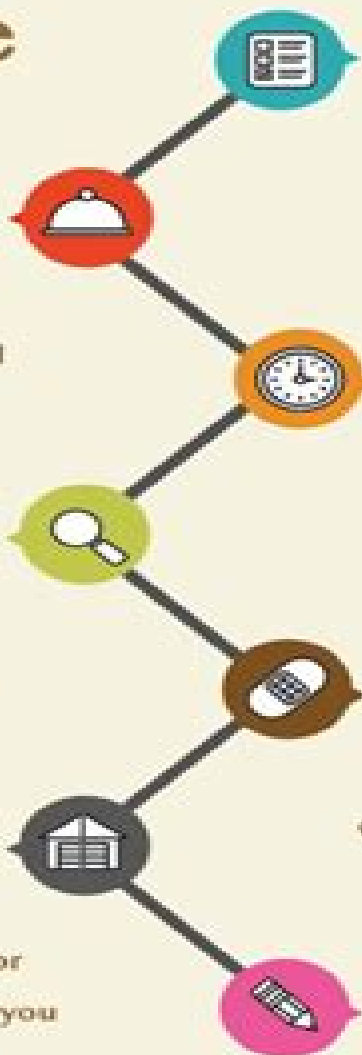
An outside individual must present the papers to your spouse. Basically, this lets them know, officially and in a legal sense, you're filing for divorce.

Step 4: Discovery

Step 6: Judgement

There are three ways to reach a judgment and finalize a divorce: settlement, default, or trial. Which path you take will depend on if you and your spouse can reach an agreement.



Step 1: Fill out and File the Divorce Forms

This includes a Summons, the Petition for the Dissolution of Marriage, etc... Once the forms are completed you will need to file them with the court.

Step 3: Response

Once you serve your spouse or get served yourself, the respondent has 30 days to file a response, with the court.

Step 5: Temporary Orders

During the divorce you may request temporary orders such as child custody, child support, or spousal support to be put in place before the final orders.

Step 7: Sign Final Documents

Once you reach a final divorce agreement the court examines the paperwork, makes sure everything is in order, and signs off.
