Once you serve your spouse or get served yourself, the respondant has 30 days to file a response, with the court.

Step 5: Temporary Orders

During the divorce you may request temporary orders such as child custody, child support, or spousal support to be put in place before the final orders.

Step 7: Sign Final Documents

Once you reach a final divorce agreement the court examines the paperwork, makes sure everything in order, and signs off.
