In the U S these reforms are rationalized based on intermediate variables like the number of math credits completed in high school and net prices. However the reforms rationalized based on this research are seldom evaluated in relation to outcomes i.e. measures of student achievement and equal opportunity to attain an education. In Education and the Public Interest the editor re-examines the political rationales for these reforms. John Rawls's theory of justice is reconstructed to develop a framework for assessing the effects of public policy on these outcomes.
