DEFINITION

The ad hominem fallacy occurs when someone attacks the character or personal traits of an opponent rather than addressing the substance of their argument.

This tactic is used to undermine the opponent without engaging with the actual issue at hand. It's a diversionary tactic that can be misleading.

EXAMPLES

- **Political Smear Campaign:**
Instead of addressing the policy proposals of a rival candidate, one focuses on rumors about their personal life.
- **Questioning Credentials:**
Dismissing a scientist's climate change research by saying they aren't a "real" scientist, rather than addressing the data.
