mandatoriness self efficacy and psychological ownership are influential in predicting employees BYOD security policy compliance Specification of security policy is associated with perceived mandatoriness while BYOD IT support and SETA are significant towards self efficacy Unexpectedly security culture has been found to have no significant relationship to BYOD security policy compliance Theoretical practical and methodological contributions were discussed and suggestions for future research were recommended The analysis led to a number of insightful findings that contribute to the literature and the management which are predominantly centered on traditional computing In view of the ever increasing BYOD threats to the security of government information it is imperative that IT managers establish and implement effective policies to protect vital information assets Consequently the findings of this study may benefit policymakers particularly in the public sector in their efforts to increase BYOD security policy compliance among employees
