eliminated straight away: this is not a book about Finland and its relations to the Soviet Union, nor is it held that these relations are necessarily a good case of what is referred to in this book as "adaptive acquiescence", a term which according to the author would be more appropriate because unlike Finlandization it is part of a comprehensive typology and does not have negative value-associations. The title of the book, which suggests the opposite, is,

therefore, somewhat confusing.

One possible misunderstanding should be

The nature and dynamics of the relations between regimes — or other social units — and their environment are the central theoretical focus of this book. In each of these relations there exists a value account or balance. Depending on the distribution of power and other factors these balances (the net result of exchanges) can be positive. negative. balanced, or negligible (when no exchange takes place). Corresponding with each of these balances there is a corresponding reaction from the unit in question. In the case of an unfavorable balance we speak of acquiescence. The reactions can be organized or non-organ-

ized. In the case of organized reactions we

can distinguish between four corresponding

"modes of adaptation" (domination, quiesc-

ence, balance, and adaptive acquiescence). If the effect is negative, i.e. when the unit is under net pressure from its environment, adaptation may also take the form of passivity (non-organized acquiescence) or of enthusiasm (non-adaptive acquiescence, the puppet regime). If such enthusiasm is lacking and regimes yet acquiesces in the hope of making the best out of an awkward situation we can speak of adaptive acquiescence. This type of regime orientation or mode of adaptation is the central topic of this book. Put briefly, the aim of the book is theoretical and nomothetical: "to conceptualize adaptive acquiescence, and investigate its methods, dynamics and inertia" (p. 6).

After a number of theoretical exercises and excursions, adaptive acquiescence is finally defined in Chapter 6 (why not at the very end of Part 1?), as (my summary): a situation in which a regime is under pressure from the environment to which it adapts by continuously and deliberately tolerating value losses, or infringements on declared values in exchange for increasing the probability of preserving core values. That is the purpose of adaptive acquiescence, which could also be called an active form of resignation. A certain minimum of defensive power or external autonomy is required for this purpose. One may question whether the best term for this is 'adaptive acquiescence' or rather 'acquiescent adaptation'. Anyway, adaptive acquiescence can be distinguished from other forms of adaptation by looking at what happens to the value account.

Adaptive acquiescence can lead to direct concessions to a dominant, challenging actor or, indirectly, to another actor perceived as an ally against the perceived unfavorable conditions. The concessions need not necessarily be directed at a specific other actor (Chapter 7). The book concentrates on one subtype: the direct version vis-à-vis an actor.

Adaptive acquiescence is not conceived of as a single policy or a set of policies but rather as an enduring pattern of behavior over a period of time, for which the term "foreign policy era" is used. This allows one to inspect how regimes, as part of an orientation of adaptive acquiescence, can use a number of strat-
