Pennoyer v. Neff

Instant Facts: A state court entered a default judgment against a nonresident of the state. The defendant argued that the judgment against him was deficient.

Black Letter Rule: The courts of a state have jurisdiction only over people or property physically located within the boundaries of that state.

Hess v. Pawloski

Instant Facts: Hess (D), a resident of Pennsylvania, injured Pawloski (P) in a motor vehicle accident in Massachusetts. Hess was served with process through the Registrar of Motor Vehicles, pursuant to a state statute that made the Registrar an out-of-state driver's agent for service of process.

Black Letter Rule: A state statute that provides that an out-of-state motorist who operates a motor vehicle in the state consents to appointment of an agent for service of process in actions that relate to the operation of a motor vehicle does not deprive the motorist of due process of law.

International Shoe Co. v. Washington

Instant Facts: A corporation headquartered in Missouri regularly solicited orders in Washington through salesmen who resided in Washington. The State of Washington sued the corporation for unpaid unemployment taxes.

Black Letter Rule: An out-of-state resident may be subject to the jurisdiction of another state's courts if there are certain minimum contacts with the state so that the exercise of jurisdiction does not offend traditional notions of fair play and substantial justice.
