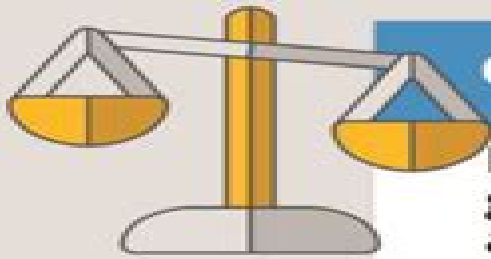

totally silent on the subject of politics Even while in prison he wrote without regret of his decision to follow Mississippi out of the Union and of his unswerving belief in the constitutionality of state rights and secession Likewise he praised all who supported the Confederacy with their blood and who like himself had lost everything
