
# Freedom of the Press Exhibit: 1791 First Amendment



In 1791, the First Amendment, part of the Bill of Rights, was authored. Noteworthy is the freedom of the press clause which continues to be the subject of court and constitutional interpretations It states, "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise there of; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."
