- ◆ The jurisdiction granted to the judicial branch is limited to federal and constitutional laws.
- ◆ The Supreme Court decides arguments about the meaning of laws, how they are applied, and whether they break the rules of the Constitution. A court's authority to decide constitutionality is called judicial review.
