Uniform Individual Accident and Sickness Policy Provisions Law

- Developed by National Association of Insurance Commissioners (NAIC)
 - Adopted in all states
 - Established standard provisions included in all health policies
-
1. Entire Contract
 - Policy
 - Copy of signed application and attached riders/amendments
 - o NO changes made after signed
 - o Only executive offer of company can change
 2. Grace Period
 - Period of time after the premium due date before policy lapses.
 - o 7 days for weekly premium policies
 - o 10 days for monthly premium policies
 - o 31 days for all other modes
 - Coverage continues during grace period
 3. Reinstatement
 - If premium is NOT paid by end of grace period, policy will lapse (terminate)
 - Reinstatement is automatic if company accepts policy premium → no reinstatement app
 - o If app is required, conditional receipt is issued w/payment
 - o Company may approve or disapprove reinstatement app
 - o Coverage reinstated within 45 days from receipt
 - o Accidents will be covered immediately
 - o Sickness is covered only after 10 days
 4. Change of Beneficiary
 - Policy owner can change beneficiary anytime by writing request to insurer
 - o Unless the beneficiary is **designated as irrevocable**
 - Consent of beneficiary no required
 - o If beneficiary is **designation is revocable**
 - Policyholder must obtain permission from beneficiary for changes
 5. Claims Procedures
- Notice of Claim**
- o Insured's duty to provide insurer with reasonable notice in the event of a loss
 - Notice required within **20 days of loss**
- Claims forms**
- o Company supplies this to the insured within specified amount of days upon receipt of notice of claim
