Short selling can be a lucrative way to profit if a stock drops in value, but it should be used only after a careful risk assessment.

1



When you are convinced a stock is more likely to fall in value than rise, you can send a short order to your broker.

2



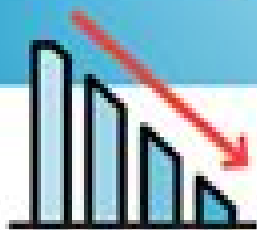
Your broker will lend you some shares of that stock and sell them on your behalf.

3



You gained cash from the sale but now you have a debt obligation to repay the borrowed shares.

4



Over time, if the stock really falls and the price drops, you will be able to pay less to buy back the same amount of shares (to repay your broker.)

5



You can keep the price difference as your profit.
