The Constitution also contains ambiguities, particularly concerning the separation of church and state, the right to privacy, and the concept of a jury of one's peers. While the First Amendment prohibits the establishment of a national religion and religious tests for lawmakers, the document does not explicitly state the separation of church and state. Similarly, the Fourth Amendment protects against "unreasonable searches and seizures," but the term "privacy" is not directly mentioned, leading to varying interpretations over time.
