Hurley, 2011-05-15 Sprawl is one of the ugliest words in the American political lexicon Virtually no one wants America's rural landscapes farmland and natural areas to be lost to bland placeless malls freeways and subdivisions Yet few of America's fast growing rural areas have effective rules to limit or contain sprawl Oregon is one of the nation's most celebrated exceptions In the early 1970s Oregon established the nation's first and only comprehensive statewide system of land use planning and largely succeeded in confining residential and commercial growth to urban areas while preserving the state's rural farmland forests and natural areas Despite repeated

political attacks the state's planning system remained essentially politically unscathed for three decades. In the early and mid 2000s however the Oregon public appeared disenchanted voting repeatedly in favor of statewide ballot initiatives that undermined the ability of the state to regulate growth. One of America's most celebrated success stories in the war against sprawl appeared to crumble inspiring property rights activists in numerous other western states to launch copycat ballot initiatives against land use regulation. Much of the preparation of this book has been generously supported by the Lincoln Institute of Land Policy, Cambridge, Massachusetts. It evolved from a colloquium held in October 1977 under the sponsorship of the Lincoln Institute. The three-day symposium entitled *Land Policy: Making the Value Choices* involved the preparation of major papers and formal discussions, most of which appear here in considerably revised form along with additional pieces commissioned later. The colloquium was an idea jointly conceived by myself and Edward Wood, a colleague at the time in the Tufts University Program in Urban Social and Environmental Policy. We were concerned about two major limitations in the literature and debates over land use. On the one hand, there was little explicit recognition of the latent values that motivated land use policy. On the other, there was no common forum where people from the different land use fields could discuss the issues and learn from one another. A small group of about two dozen people was invited to the colloquium. Each member was a leading spokesman for a different perspective and area of expertise. All participated formally.
