Inequity and Madness José Guimón, 2012-12-06 Two of the most important notions concerning the rights of people with mental illness are among the most neglected the first is that human rights and duties are complementary and that both must be considered in constructing a framework for mental health care The second is that we must strive for equity and not only for equality in developing mental health programs The first of these notions is complex It refers to the duties of people with mental illness and to the duties of those who surround them Mental illness does not liberate the person who has it from civic obligations The most basic of these is to give support to others and to refuse to harm them Their carers society and the patient's self respect all gain through their recognition even though the fulfilment of these obligations might be difficult or impossible in certain periods of illness The duty of those surrounding the patients is to recognise and respect their existence and to make the necessary arrangements to respond to their needs protect their rights and compensate for their temporary or permanent inability to fulfil their civic duties A society's social capital is the public good that results from the mutual support of members of a society if for one reason or another some or all members of a society fail to offer such support the social capital will diminish and the society will cease to be civic
