Physical

Having physical child custody means that the child lives with you



Joint

The child resides with both parents and takes turns living with each parent so that both parents are part of the child's life on a regular basis

Sole

The child resides with one parent. In this case, the other parent is usually allowed visitation.

Legal

Having legal child custody means you have legal authority to make decisions for the child



Joint vs. Sole

Either one or both parents make decisions for the child

Decisions

The parent has the right to make decisions about the child's health, education, religion and welfare.

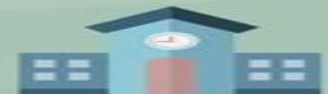
