The Multiple Linear Regression Model

$$Y_i = \beta_0 + \beta_1 X_{1i} + \beta_2 X_{2i} + \beta_k X_{ki} + u_i$$

Hence for each i , we have data on k regressors and the dependent variable.

- $\beta_0, \beta_1, \dots, \beta_k$ are unknown real constants
- u is an unobservable random variable
- Model is called a linear regression model with k regressors or a multiple linear regression model.
- $\beta_0 + \beta_1 X_1 + \beta_2 X_2 + \dots + \beta_k X_k$ is called the population regression line or the population regression function.
- β_j is referred to as the slope of for the j th regressor, where $j = 1, 2, \dots, k$
- β_0 is called the intercept
- β_0, \dots, β_k are called the coefficients or the parameters of the regression function.
