I. THE COMMON LAW MIND: THE NATURE OF THE BEAST

The common law frame of mind continues to overshadow the way we teach, write and think about law. Its categories and assumptions are still the standard diet of most first-year law students; and they continue to organize law textbooks and case-books. Stated baldly,¹ it assumes that although law may appear to be irrational, chaotic and particularistic, if one digs deep enough and knows what one is looking for, then it will soon become evident that the law is an internally coherent and unified body of rules. This coherence and unity stem from the fact that law is grounded in, and logically derived from, a handful of general principles; and that whole subject-areas such as contract and torts are distinguished by some common principles or elements which fix the boundaries of the subject. The exposition and systematization of these general principles, and the techniques required to find and to apply them and the rules that they underpin, are largely what legal education and scholarship are all about.

Its message is reassuring. In any particular situation there is such a thing as the one true rule of law. Students can tease it out from the mass of competing alternatives, once they have learnt the technique. And that technique asserts that law (i.e. case-law) is a unified and internally coherent whole. In this way law is a species of science. It is objective, neutral and apolitical. Knowing the law is largely defined as learning this technique and the basic (overwhelmingly case-law) rules of "core" subject-areas such as contract, torts and so on. Of course, the claim that law is unified and coherent does not simply depend upon the assertion that the law is ultimately grounded in a small number of general principles. It is also sustained by a battery of distinctions – common law/statute law, law/politics, law/state, law/morality, legal/empirical, technique/substance, form/substance, means/ends, private law/public law, law/history, law/theory – that make it more tenable to regard law as "pure" and "scientific". The common law becomes the nucleus of legal education and scholarship.
