# HIV/Aids and the Law

There is not legislation regarding HIV in South Africa as yet, mostly it revolves around gender as women are more prone to contracting the disease.

#### Statistics.

- ✓ An estimated 5.3 million South Africans are living with HIV/Aids, which is the highest total of people living with HIV/Aids in the world.
- It destroys the family structure
- ✓ There is an increase in HIV prevalence amongst women attending antenatal clinics (from 0.7% in 1990 to 26.5% in 2002). (this is only pregnant women):
- ✓ It is projected that women's life expectancy will decrease from 25 (2001) to 37 (2010) and in men 49 (2001) to 36 (2010).
- In South Africa, the majority of persons living with HIV/Aids are women and girls.
- ✓ An estimated 57% of all cases of HIV/Aids among adults aged 15-49 are women.

#### The role of Gender-specific violence HIV Transmission

- Women and girls are physiologically more vulnerable than men and boys, to contracting the HIV infection during unprotected heterosexual sex.
- In cases of gang rape, exposure to multiple assailants increases the risk of transmission
- Women and girls in abusive relationships may have limited capacity to negotiate the terms and conditions of sex, including when and whether sex takes place and whether condoms are used.

#### South African Government Interference with Antiretroviral Drug Provision

- August 2001: a coalition including the TAC sued the government to provide antiretroviral drugs in the public sector to all HIV-positive women to prevent mother-to-child transmission
- December 2001: Pretoria High Court ruled that the government refusal to provide antiretroviral drugs to HIV-positive pregnant women violated the Constitution and ordered it to provide these medications. Tshabalala-Msimang announced that she would seek leave to appeal the decision directly to the Constitutional Court

#### South African Law

- There is not an actual act relating to HIV in South Africa so the legal authority usually referred to is the Constitution.
- There are numerous rights listed in the Constitution which can be used in terms of HIV
   Right to equality (\$9)
- Right to dignity (\$10)
- ✓ Right to health care (\$27)
- Right to physical and psychological integrity (\$12(2))
- ✓ Right to life (\$11)
- The Constitution prohibits all unfair discrimination against anyone directly or indirectly on the basis of sex, gender or pregnancy.
- Children's rights include the right to basic health care and social services and the right to be protected from maltreatment, neglect, abuse or degradation.
- ✓ The Constitution further provides that: "(a) child's best interests are of paramount importance in every matter concerning the child".
- There is also the right to not be refused medical treatment such as if someone has a CD4 count of less that 200
- According to the Constitutional Court, "the purpose of this right is to ensure that treatment be given in an emergency and is not frustrated by reason of bureaucratic requirements or other formalities. What the section requires is that the remedial treatment that is necessary and available be given immediately to prevent harm".
