Seller/Builder shall provide and pay for all labor, materials, equipment, tools, clean-up, utilities, transportation, facilities, permits, fees, licenses, and all other costs, charges and expenses whatsoever in connection with or related to the construction of the *House*. *Seller/Builder* shall pay all costs, and other expenses, of any nature whatsoever, for *Seller/Builder's* construction financing of the *House* including real estate commissions or fees, if applicable.
