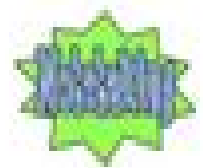
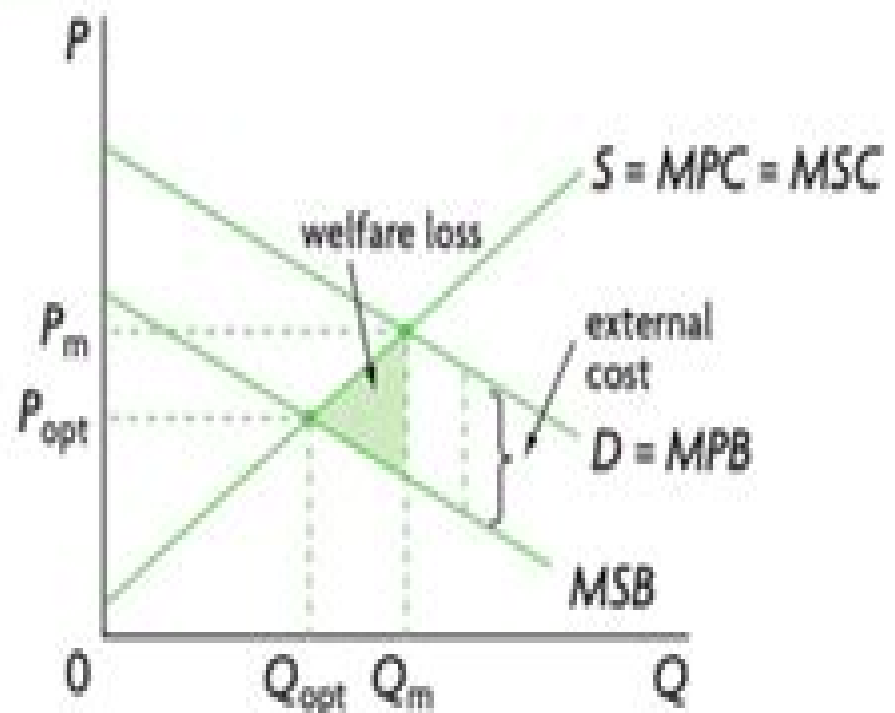


Welfare Loss of Negative Consumption Externalities
