

The limits of globalization – legal and political issues in e-commerce

Abstract

This article analyses some of the most important political and legal challenges faced by internationally operating Internet firms today. In addition to dealing with an important, albeit rarely discussed, issue, the present article attempts to provide a fresh perspective on this topic by utilising the concept of political risk. Using evidence from exemplary court cases on topics such as consumption tax and intellectual property rights, the discussion demonstrates that Internet firms face serious political and legal uncertainties, which differ considerably between different markets. The article reveals that, in the age of globalization, national boundaries still matter a great deal. In terms of methodology, the article portrays how legal materials can be used to understand the impact of legal and political processes on international firms. Indeed, it suggests that future business research could make greater use of factual evidence from litigation as an alternative methodology in the study of the business environment.

Introduction

Globalization has been one of the most hotly debated business subjects in the last decade. While definitions of globalization vary widely, perhaps the key distinguishing feature is the “permeability of traditional boundaries of every kind” including physical borders such as nation-states and less tangible borders such as cultural norms (Parker, 1998, p. 6). The Internet was often seen as an embodiment of globalization and terms such as “borderless cyberspace” were previously used to refer to it. It was hailed as a space where individuals and firms could escape the control of nation-states. Governments would not be able to effectively regulate the Internet and such regulation could even be considered illegitimate, so there would be unlimited freedom of speech, no taxes and no government regulation. Prototypical for this view, a US Treasury paper dealing with the tax implications of e-commerce stated that new communications technologies have “effectively eliminated national borders on the information highway” (quoted in Kobrin, 1997).

But such a view was inherently misleading. While the Internet poses new challenges to state officials, nation-states are unlikely to give up taxing Internet businesses or trying to regulate various aspects of Internet activities. Governments have gradually begun to regulate Internet activities including e-commerce, creating new laws or extending old laws to the Internet. From Chinese efforts to introduce Web site censorship to a series of European Union directives dealing with issues such as copyright, Internet businesses have been faced with a growing tide of Internet regulation. Indeed, Internet gurus perhaps underestimated that the success of

e-commerce may even require some regulation (which governments are best placed to provide) ranging from common international standards to the legal enforceability of electronic signatures.

The growth of government regulation entails the persistence of political and legal challenges for Internet firms. While Internet firms have perhaps less to fear from traditional political and legal risks such as expropriation, they still face other risks such as non-enforcement of intellectual property rights; uncertainty over the legal validity of electronic contracts; changes in taxation; or legal liability of Internet service providers (ISPs) for third-party content. Furthermore, as there has been increasing internationalization of e-commerce and firms increasingly derive a greater part of their income from outside the home country, Internet businesses became more vulnerable to unpredictable changes in the political and legal business environments outside the home country. Meanwhile, the regulation of e-commerce has mainly developed at the national or regional level and few common international rules have been established. An Internet firm might find that the legal and political environment in foreign markets may be very different from that of the home country. Thus, political and legal events in foreign countries are likely to play some role in the expansion of e-commerce.

Unfortunately, the rapidly expanding business and management literature on e-commerce appears to have neglected the political and legal environment. The academic writing on e-commerce in mainstream business publications concentrates on purely commercial concerns such as strategic management issues (e.g. Porter, 2001; Mellahi and Johnson, 2000), marketing issues (e.g. Reichheld and Scheffer, 2000; Kenny and Marshall, 2000) or supply chain management issues (e.g. Landoni et al., 2000).
