

philosophy chiefly because the neurotypical linguistic and cognitive behaviour of humanity at large is at variance with them Using the resources of a causal response epistemology in tandem with the naturalized logic the theory produced here is data driven empirically sensitive and open to a circumspect collaboration with the empirical sciences of language and cognition
