### INTRODUCTION

Today's societies require increasing amounts of energy for domestic, industrial, commercial, agricultural, and transport uses. These energy needs are met by the commercial energy sources including the short-term, depletable fossil fuel supplies — petroleum, coal, and natural gas — as well as the long term, renewable sources — hydroelectric, biomass, solar, geothermal, wind, and tidal power (Munasinghe and Schramm, 1983).

This paper sets out a consistent generalized framework for energy pricing in developing countries. The methodology seeks to maintain a compromise between analytical rigour and practicality. Because energy pricing is only one aspect of demand management and overall energy planning for national development, it is useful to first examine the role of pricing policy within this wider perspective.

### PRICING POLICY AND INTEGRATED NATIONAL ENERGY PLANNING

Because of the many interactions and nonmarket forces that shape and affect the energy sectors of every economy, decision makers in an increasing number of countries have realized that energy sector investment planning, pricing, and management should be carried out on an integrated basis, e.g., within a national planning framework which helps analyse energy policy options ranging from a short-run supply-demand management to a long-run natural energy strategy (Munasinghe, 1983).
